## PROCEEDINGS OF PIERCE COUNTY, NORTH DAKOTA, BOARD OF COUNTY COMMISSIONERS

## October 6, 2022

The Pierce County Board of County Commissioners met in special session on October 6, 2022. Chairman Christenson called the meeting to order at 8:00 A.M., with members Brossart, Hoffert, Bednarz and Migler present.

Chairman Christenson led the Pledge of Allegiance.

Moved by Migler and seconded by Brossart to approve the consent agenda. Motion carried.

Moved by Migler and seconded by Hoffert to accept the September minutes as mailed, with one correction: to amend the motion for transferring \$90,159.40 from HB1505 to unorganized townships for gravel, to \$90,519.40. Motion carried.

Moved by Hoffert and seconded by Brossart to approve those bills previously paid and those yet unpaid were ordered paid. Motion carried.

Board reviewed Officer fee reports and hourly workers time sheets.

Sue Sitter, Pierce County Tribune, joined the meeting.

Moved by Migler and seconded by Hoffert, to accept the financial report for the month of September. Motion carried.

Moved by Hoffert and seconded by Brossart to transfer \$100,000. from General Fund to HACTC Fund. Motion carried.

Moved by Migler and seconded by Hoffert to transfer \$15,000. from Wireless Fund to E911 Fund. Motion carried.

Moved by Hoffert and seconded by Brossart to approve Treasurer's checks #6247-#6252, in the amount of \$632.03 for the month of September. Motion carried.

Board reviewed abatement application submitted by Gwen Kleespie, for tax year 2022 (2022-15), on the following described property, as Lots 17-18, Block 14, Rugby Original, located in the City of Rugby. Moved by Hoffert and seconded by Migler, to approve the abatement application for tax year 2022, as recommended by the Tax Director, in accordance with homestead credit. Motion carried.

Board reviewed abatement application submitted by Duane Ebach, for tax year 2022 (2022-16), on the following described property, as Outlot 115 of SW1/4NW1/4, section 10, Township 155-73. Moved by Hoffert and seconded by Migler, to approve the abatement application for tax year 2022, as recommended by the Tax Director, in accordance with homestead credit. Motion carried.

Mike Graner, HACTC Jail Administrator, joined the meeting.

Mike Graner gave the Board a report for the month of September for the Sheriff's Dept., as Josh Siegler,

Sheriff, was out of town for training meetings. Total calls 59; Medical Calls-2; Fire Calls-2; Traffic Accidents-3; Assist other Agencies-17; Prisoner Transports-7; Arrests-4 Warrants; Citations-5; Papers served-15; Warrants served-4.

Board recessed to sit on the HACTC Board.

Mike Graner, Jail Administrator, HACTC went over the bills for the facility and answered any questions the Board had. Moved by Bednarz and seconded by Brossart to approve those bills previously paid and those yet unpaid were ordered paid, for the month of September, for the HACTC. Motion carried.

Graner talked about the 2013 Suburban, which has over 200,000 miles and the transmission is out. The new Suburban is not road ready yet. After checking with Kent Christenson, by phone, it was estimated to be about \$3200. to get a rebuilt transmission. The Board agreed to go ahead with that.

Mike Graner, Jail Administrator, HACTC, gave the Board a report on the inmate population at the jail facility for September, which was 90 (ADP). Current inmate count is 81. High of 98 for September. Bookings 34, Releases 42. Pierce County inmate population for September was 5. Deficit of \$14,188.42, for the month of August. Personnel 23/24 officers, 1 new hire since last meeting, reviewing 2 other applicants, 3 resignations.

Graner explained bookings were down for the month, due to another Covid outbreak, so couldn't accept as many inmates from other counties. Bottineau Co. will be bringing more inmates for 3 weeks, due to Staff training. Staff issues continue to be a challenge.

Moved by Hoffert and seconded by Bednarz, to approve the financial report for the month of August, for the HACTC. Motion carried.

Board reconvened at 9:08 A.M., with all members present.

Karin Fritel, C.O.C. and Michelle Lysne, Deputy C.O.C., met with the Board regarding the deputy's salary, since Fritel, C.O.C., was going to part time hours and Lysne, Deputy C.O.C., was going to full time hours. She felft her extra salary in the budget should go to the deputy clerks salary, as she will be working full time hours and having more responsibility. No extra is being asked, just using what's already in the budget. Hoffert questioned the fairness in the courthouse and said just because it's budgeted, doesn't mean we have to use it. After some discussion, moved by Bednarz and seconded by Brossart, to give the extra salary budgeted for the Clerk of Court to the Deputy position. Upon roll call vote- Brossart "Aye", Hoffert "Nay", Bednarz "Aye", Migler "Aye", Christenson "Aye". Motion carried.

Board held hearing on the minimum sale price for real estate acquired through tax deed action, in accordance with sections 57-28-11. No written comments were received. Board had a couple questions for the States Atty.

Board reviewed a letter from ND Dept.of Transportation about the highway/rail crossing safety program The funds are used for the installation of active warning devices, crossing signs, & crossing surface improvements. Comm.Migler encouraged the other commissioners to check their railroad intersections in their townships. They could benefit from it by building them up and making them safer.

Mike McNeff, Superintendent, Rugby Schools, joined the meeting. He gave the Board an update on the Ely Elementary project. He informed them of the challenges they faced, as the original project cost was estimated at 8.3 million, final bids are 10.6 million, funds available are 9.2 million, with a shortfall of 1.4 million. Material shortages and inflation have affected the costs. They are looking at other options without raising mill levies. The County will check if any ARPA Funds are available and could be used for this project.

Brenden Klebe, NDSU Extension Agent, met with the Board and gave them an update on the 4-H program. He reported the numbers were up last year. He told the Board that for medical reasons he will be in and out of the office. His immune system is compromised right now, so if you are planning a visit to his office, reconsider if you aren't feeling well, or just give him a call. He informed them of the NDSU Ext. Legislative Update Session which will be held on Oct. 26<sup>th</sup>, if they want to attend virtually.

Galen J. Mack, States Atty. joined the meeting. Board asked him about adding the survey costs to a parcel that was part of the delinquent property. Mack said that it could be added.

Lisa Coffman, Community Service Coordinator, met and gave the Board an update on the Community Service Program. More fees were collected and more clients. Judge Benson in Bottineau County suggested she could use Zoom for attending Court. Board told her to drive there once a month and use Zoom once a month.

Gary Laughridge met with the Board and had a discussion with a culvert issue in Christenson Township. He will try it with the culvert that is there now.

As the hour of 11:00 A.M. was past, the Chairman called for the opening of the propane, diesel fuel, and gasoline bids. Bids were received from the following:

Envision- Diesel Fuel-daily price less \$.14
Envision- Propane-\$1.79/gallon
Envision-Gasoline-net reduction from pump price, less \$.03 per gallon
Harper, Inc.-Premium Diesel & Gasoline- \$.10 discount per gallon

Moved by Migler and seconded by Hoffert to accept the bid for Diesel Fuel and Propane from Envision and Gasoline from Harper, Inc. Motion carried.

Moved by Hoffert and seconded by Brossart to sell the real estate properties acquired through tax deed action, for taxes owing for all parcels, plus survey costs for parcel #05128-000, and that the terms of the sale on November 15, 2022, be for cash only. Motion carried.

There being no further business to transact, moved by Bednarz to adjourn the meeting at 11:35 A.M., seconded by Brossart.
