PROCEEDINGS OF THE PIERCE COUNTY BOARD OF EQUALIZATION

June 7, 2022

The Pierce County Board of Equalization met in annual session on June 7, 2022. Vice-Chairman Hoffert called the meeting to order at 10:00 A.M., with members Berg, Brossart, Christenson and Migler present. Also present was Kelsey Siegler, Tax Director.

Kelsey Siegler, Tax Director, reported on the changes in assessment on agricultural, residential and commercial property. Ag land-New soil survey in Union, Wolford, Hurricane Lake and Rush Lake Townships. Countywide 93% Tolerance. Overall Ag Land decreased 1%. Residential- Manual level was adjusted from 110 to 120. Commercial-no change.

All organized townships approved their assessment except for Truman Township, they denied inundated application from Marlene Ripplinger. White Township denied inundated application from Gary L.Mayer Irrevocable Trust.
